# Seneca County Chamber of Commerce Membership Investment Schedule

Average number of employees annually at all business locations within Seneca County or the next closest single location if located outside the county. Two part-time/seasonal employees equal one full-time. Base rate includes one owner. Dues are to be paid annually and must be paid in full with application.

## **Agricultural, Colleges & Universities, Construction, Manufacturing, Restaurants, Retail, Services, Wholesale, Misc.**

\$230 + \$2 per full-time equivalent employees

**Financial Institutions** – Based upon local deposits at all branches within Seneca County or the closest single location if outside the county.

\$230 + \$16 per million of local deposits  
Maximum investment = \$1,100

## **Hotels, Motels and Bed & Breakfasts**

1 – 20 Rooms = \$230  
21 Rooms + = \$230 + \$2 per room over 20

## **Hospitals/Nursing Homes**

1 – 20 Rooms = \$230  
21 Rooms + = \$230 + \$2 per room over 20

## **Major Employers w/400 + employees**

\$2000 + \$4 per full-time equivalent employee

## **Non-Profit Charitable Organizations/Government**

\$200

## **Professionals – Accountants, Architects, Attorneys, Consultants, Dentists, Doctors, Insurance Agents, and Real Estate** - Includes primary level professional only.

Example: Doctors offices should include doctors only, not nurses.

\$230 + \$30 per additional partner or primary-level professional

## **Public Utilities**

\$230 + \$.03 per active meter

## **Individual Members**
